





TO: All Game and Fish Personnel
FROM: C. J. Rice, Chief *CJR*
Enforcement Division

At the regular meeting of the Arkansas Game and Fish Commission, September 17-18, 1973 held in El Dorado, Arkansas, Millwood Reservoir was inadvertently opened to commercial fishing with 3½" or larger bar mesh gill and trammel nets only.

Millwood Reservoir should be removed from the list of lakes that was acted upon at that meeting and will be open to commercial fishing as all other public waters in that area provided for in both the Arkansas Game and Fish Commission Code Book and the 1973 Fishing Regulation pamphlet.

Delete Millwood Reservoir from Commission Order 009.73 that was made effective October 1, 1973.

Reciprocal License Agreement between Arkansas and Missouri -

Licensees must abide by the rules, law and regulations governing fishing in the State issuing the license.
