At least 20 days before the regular monthly meeting of the Commission, the Director shall publish in one or more newspapers having general daily circulation a notice of the time, date and place of such meeting and the subject of any proposal for the adoption, amendment or revocation of any regulation to be considered at such meeting.

Any person wishing to be heard on any of the published subjects shall submit comments in writing to the Director on or before seven days prior to the regular monthly meeting.

Any person wishing to be notified of a regular meeting of the Commission in advance thereof shall file a written request with the Director who shall inform such person by mail notice of such meeting in the same form as the published notice.

Subject: Emergency regulations

O R D E R

EMERGENCY REGULATIONS. NOTICE AND EFFECTIVE DATE.

If the Commission finds that eminent peril to the public health, safety or welfare requires adoption of a regulation as an emergency measure, it may proceed to adopt such regulation without notice, provided a statement of the reasons for the finding that such emergency exists together with a certified copy of the regulation adopted is filed for registration by the Director with the Governor, Secretary of State and the Circuit Clerk of each county. All emergency regulations shall become effective immediately upon filing and shall remain in effect for a period of one hundred twenty (120) days thereafter unless otherwise specified by the Commission.

Upon the adoption of an emergency regulation the Director shall publish a copy of same with the date and time the same shall be effective in one or more newspapers having general daily circulation.
