ORDER


In order to establish a boating safety program for the operation of vessels on any of the waters of the state that are maintained and controlled by agencies of the federal government, the following United States Coast Guard boating regulations are adopted for the promotion of safety in the operation of vessels on such waters;

- 33 CFR 173-174;
- 33 CFR 175;
- 46 CFR 25.


