

Amends Code Book Section 71.05 (Item #1 - dated August 1, 1973)

- The use of any motor in excess of 10 horsepower is prohibited.  
(EXCEPTIONS: Party Barges may use up to and including 25 horsepower and authorized commercial boat docks will be required to have an emergency boat with sufficient horsepower to answer any emergency that might arise, regardless of lake conditions.)  
The 10 horsepower restriction shall not apply to Lake Enterprise, Upper Lake Chicot, Grand Lake, Calion Lake and Lake Hinkle (except where zoned.)

It shall be unlawful to hunt any wild game on the Lafayette County Wildlife Management Area on October 25, 26, 27, 1974 without first obtaining a permit from the International Paper Company whose address is:

(Permits cost \$10.00 each.) Only one (1) deer (bonus deer) and other in-season game may be taken.

October 25-26, 1974 -- Bucks only.

All game taken must be checked at Check Stations before leaving the management area.

Camping is permitted in designated areas.

PENALTY: \$25.00 to \$300.00

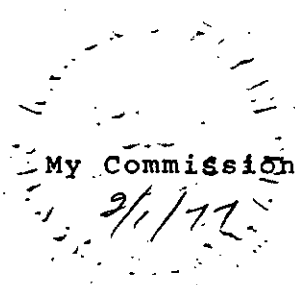
