
AMENDS COMMISSION ORDER 016-76
COMMISSION CODE BOOK SECTION 60.31

SALE OF COMMERCIAL FISHES: Effective July 1, 1977, it shall be unlawful to sell commercial species of fish, taken from the waters of this State, unless the seller possesses a current, annual Commercial Fisherman Permit, a Fish Farmer Permit or Put and Take Pay Lake Permit (whichever is applicable). A bill of sale must be given the purchaser for each transaction of sale to markets, processors or retailers, and the applicable Permit number shall be placed on each bill of sale. The bill of sale shall be retained by the purchaser for twelve months and made available to employees of the Arkansas Game and Fish Commission upon request. This section does not apply to the resale of fish for which a valid bill of sale has previously been tendered and is available for inspection.

PENALTY: \$100.00 to \$500.00.
