

TRAINING BIRD DOGS ON CAMP ROBINSON WILDLIFE DEMONSTRATION AREA. Unlawful for any person not a resident of Arkansas to train bird dogs on CAMP ROBINSON WILDLIFE DEMONSTRATION AREA; current hunting license required. It shall be unlawful for any person to have on the Wildlife Demonstration Area more than six bird dogs during any one-day period, and dogs must not be penned overnight on the area, except during approved field trials.

PENALTY: \$25.00 to \$250.00.







TRAINING BIRD DOGS ON CAMP ROBINSON WILDLIFE DEMONSTRATION AREA. Unlawful for any person not a resident of Arkansas to train bird dogs on CAMP ROBINSON WILDLIFE DEMONSTRATION AREA; current hunting license required. It shall be unlawful for any person to have on the Wildlife Demonstration Area more than six bird dogs during any one-day period, and dogs must not be penned overnight on the area, except during approved field trials.

PENALTY: \$25.00 to \$250.00.


