Subject: COMMERCIAL FISHING

O R D E R

It shall be unlawful to fish for commercial purposes with any commercial tackle in Blue Mountain Lake except from July 1, 1977 through September 30, 1977, and only three inch or larger square bar mesh gill and trammel nets may be used.

PENALTY: \$50.00 to \$250.00

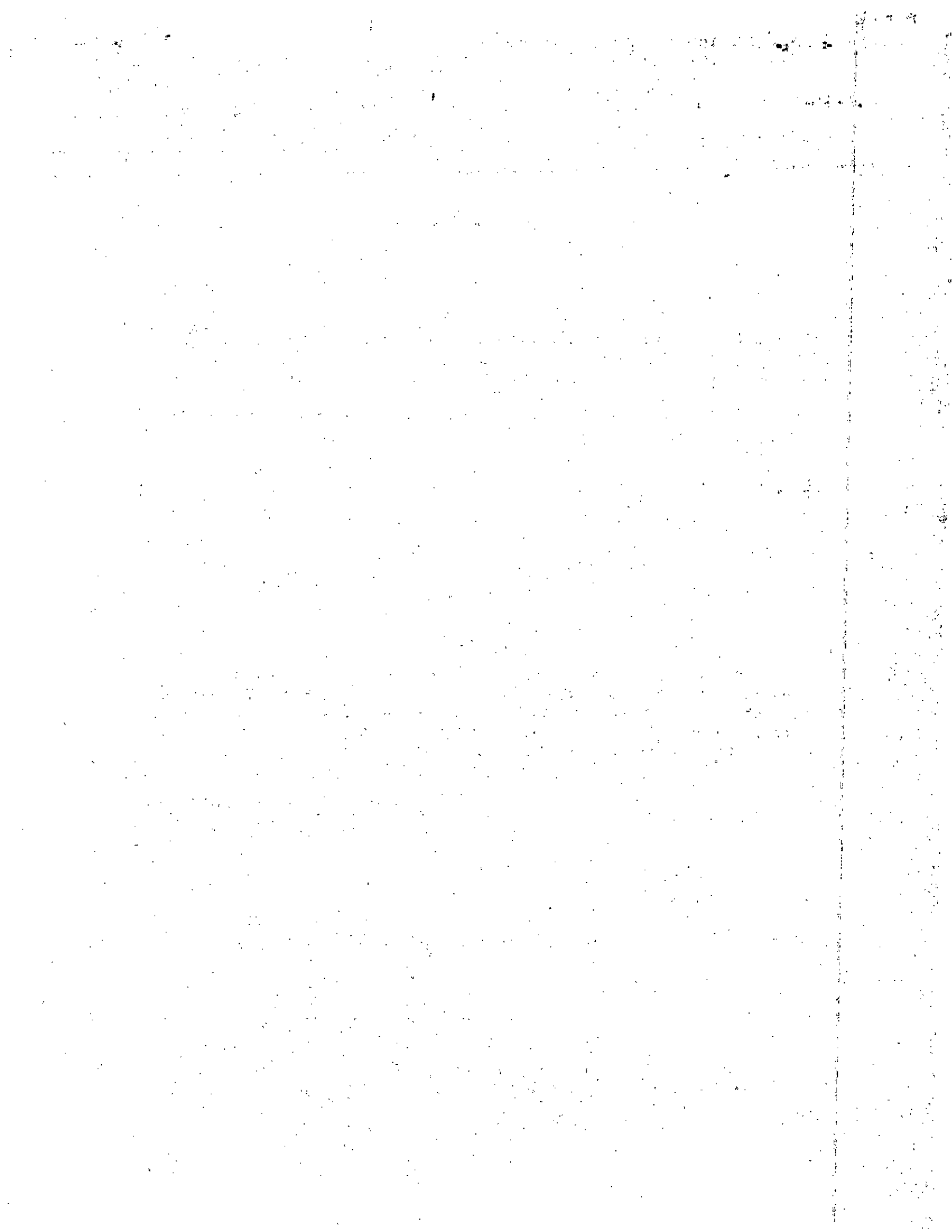

O R D E R


It shall be unlawful to fish for commercial purposes with any commercial tackle in waters as listed below: EXCEPT as provided in this order.

- (1) Calion Lake - Union County - Open December 1, 1977 through December 31, 1977, both dates inclusive. Only Three and one half inch square bar mesh (or larger) trammel and gill nets may be used.
- (2) Big Robe Lake - Dagmar Wildlife Management Area - Open September 1, 1977 through April 30, 1978, both dates inclusive. Only three and one half inch square bar mesh (or larger) trammel and gill nets may be used.
- (3) Burnt Cane Lake - Saint Francis County - Open September 1, 1977 through April 30, 1978, both dates inclusive. Only three and one half (or larger) square bar mesh trammel or gill nets may be used.

PENALTY: \$50.00 to \$250.00


