FUR TAKER PERMIT. Unlawful for a person or persons, of any age, to use, set or run snares or traps or for a person or persons, of any age, to take or possess fur-bearing animals or any part thereof by hunting, trapping or any other means without first obtaining a current and appropriate (resident or non-resident) Arkansas Fur Takers Permit except persons when taking fur-bearers as allowed under Sections 35.04 or 48.06 are exempt from this regulation.

PENALTY: Resident: \$25.00 to \$250.00

Non-Resident: \$100.00 to \$300.00
