SPECIAL

It shall be unlawful to fish Millwood Reservoir, including the Cossatot and Saline River up to State Highway 24, Little River up to the Oklahoma State Line, and Mercer Bayou (Miller County): EXCEPT from noon, September 4, 1979 through noon, May 1, 1980. Three (3) inch or larger gill and trammel nets and other commercial tackle as declared legal by the Arkansas Game and Fish Commission may be used in Millwood Reservoir and Mercer Bayou.

Commercial Fishing on waters as mentioned above shall revert back to statewide regulations after 12:00 noon, May 1, 1980.
