O R D E R1979-80 SMALL GAME SEASONS AND BAG LIMITS.

SQUIRREL (FALL)

September 15, 1979 through January 15, 1980, North of I-40.
October 1, 1979 through January 31, 1980, South of I-40.
Daily Limit - 8. Possession Limit - 16. Dogs allowed.

SQUIRREL (SPRING)

May 15, 1980 through June 15, 1980. Daily Limit - 8.
Possession Limit - 16. No dogs allowed.

QUAIL

November 15, 1979 through February 15, 1980.
Daily Limit - 8. Possession Limit - 16. Dogs allowed.

RABBIT

October 1, 1979 through February 15, 1980.
Daily Limit - 8. Possession Limit - 16. Dogs allowed.

CROW

September 1, 1979 through December 31, 1979. No limit.

FURBEARERS (HUNTING)

Noon, November 29, 1979 through January 31, 1980.
Limit - 4 raccoons per properly licensed individual.
No limit on other furbearers.

FURBEARERS (TRAPPING)

Noon, November 29, 1979 through January 31, 1980.
No limit.
