NIGHT HUNTING. It shall be unlawful to hunt or kill any wild animal, or wild bird at night with or without the use of a light of any type.

Exemptions:

- (1) Under permit issued by the Arkansas Game and Fish Commission.
- (2) The taking of furbearing animals when treed by dogs during open furbearing season.
- (3) The taking of frogs by legal methods during open bullfrog season.

PENALTY: \$250.00 to \$1,000.00. In addition, a jail sentence not to exceed one (1) year and/or suspension of hunting and fishing privileges for a period of twenty-four (24) calendar months may be imposed. Equipment used in such violations (including but not limited to killing devices and lights) may be confiscated by the court, forfeited to the state and disposed of according to law.

O R D E R

NIGHT HUNTING. It shall be unlawful to hunt or kill any wild animal, or wild bird at night with or without the use of a light of any type.

Exemptions:

- (2) The taking of furbearing animals when treed by dogs during open furbearing season.
- (3) The taking of frogs by legal methods during open bullfrog season.

PENALTY: \$250.00 to \$1,000.00. In addition, a jail sentence not to exceed one (1) year and/or suspension of hunting and fishing privileges for a period of twenty-four (24) calendar months may be imposed. Equipment used in such violations (including but not limited to killing devices and lights) may be confiscated by the court, forfeited to the state and disposed of according to law.
