O R D E R

DUCK DAILY BAG AND POSSESSION RESTRICTIONS. It shall be unlawful to take or attempt to take more ducks in any one day than as specified under the point system or to possess more than two (2) daily bag limits:

Daily bag limit is reached when the point value of the last duck taken, added to the sum of the point values of ducks already taken during that day, reaches or exceeds 100 points.

Point values for ducks will be:

Canvasback -- 100

Female mallard, redhead, wood duck, black duck and hooded merganser -- 70

Widgeon, pintail, blue-winged teal, cinnamon teal, gadwall, shoveler, scaup, green-winged teal and mergansers (except hooded mergansers) -- 10

Mallard drake and all other species of ducks -- 25.

PENALTY: \$25.00 to \$250.00

O R D E R

DUCK DAILY BAG AND POSSESSION RESTRICTIONS. It shall be unlawful to take or attempt to take more ducks in any one day than as specified under the point system or to possess more than two (2) daily bag limits:

Daily bag limit is reached when the point value of the last duck taken, added to the sum of the point values of ducks already taken during that day, reaches or exceeds 100 points.

Point values for ducks will be:

Canvasback -- 100

Female mallard, redhead, wood duck, black duck and hooded merganser -- 70

Widgeon, pintail, blue-winged teal, cinnamon teal, gadwall, shoveler, scaup, green-winged teal and mergansers (except hooded mergansers) -- 10

Mallard drake and all other species of ducks -- 25.

PENALTY: \$25.00 to \$250.00
