1. Submissions are due on or before the dates listed below.
2. OHA allows for a 2-week grace period to work with the APAC data vendor, Milliman, to correct errors in submissions. If errors cannot be corrected within the 2-week grace period, the mandatory reporter must submit an exception request to receive an extension.
3. Mandatory reporters that have not correctly submitted data or received an exception within 14 calendar days of notification of error will be considered non-compliant, and OHA may take action to impose penalties, as outlined in OAR 409-025-0150.
